### ABSTRACT

My name is CJ Ehrlich, I'm transgender (female to male), currently four years on hormones. This study examines the healthcare experiences of transgender and non-binary individuals and their interactions with healthcare providers. This study comprised 83 participants, 3 interviews, and plus a total of 15 hours of observation study- I went online to look at healthcare providers reviews to see what they patients were saying, what the stars were on the websites, and where the doctors were located. The solution is an app that will help the community find things like transgender and non-binary friendly healthcare providers (the main focus of the app).

### **INTRODUCTION**

My name is CJ Ehrlich, and I'm in my senior year of completing my Bachelor of Science Degree in Interaction Design (IxD). I'm transgender (female to male). In 2020, During this time, I was going back and forth with my gynecologist, who treated transgender patients but didn't want to take me as his patient. They were disrespectful. In August 2020, I wanted a total hysterectomy to remove an ovarian cyst. The gynecologist's office did not want to do a total hysterectomy, and they did not provide me with an option to remove the cyst.

My research influences the development of my Senior Project by creating an area for reviewing healthcare providers that others have gone to. Users can filter out the healthcare providers that have the great stars to the worst stars reviews. The research revealed a need for accessible healthcare providers who offer a welcoming and non-judgmental environment, especially since it is difficult to find a great provider who won't judge or rush. The research also shows me that both the transgender community and the non-binary youth are expecting barriers that they are getting from the healthcare providers.

# **The Problem Statement**



## **PROPOSED METHOD**


- •Based on the data collected the participants were in between the ages of 18 to 71.
- I did: 3 rounds of surveys, 3 interviews, and 15 hours of Observation study

- \* During one of my 3 surveys rounds, I asked "I have been feeling doubtful about the decisions made by my healthcare answered neutral, 2 people Strongly Agree, and 7 people decisions made by they healthcare providers. The research period was from September 2023 to January 2024.
